## REACH – Declaration of Conformity

REACH became effective on the 1st of July 2007. Manufacturers of chemicals and preparations have to register their substances. Substances > 1 to which are produced or imported into the EU have to be registered (this is also valid for preparations, mixtures and special manufactures). Registered substances are considered as safe chemicals (in single cases under risk-minimizing-measures). The registration has a transition period of 3 to 11 years (Art. 23) depending on the amount and classification of the chemicals and their health-/environment-influence. It is of need to pre-register the chemicals by the manufacturer / importer to make the validity of the transition period possible.

Concerning the REACH Regulation HANNO WERK GmbH & Co.KG is a producer of materials for joint sealing and acoustic insulation and therefore a "downstream user" of chemical substances and preparations. According to the EC Regulation no. 1907/2006 (REACH) and the manufacture of the HANNO works, only products are involved. These are not subject to registration and are therefore not registrable as REACH only refers to substances. Out of REACH HANNO derives, that therefore no safety data sheets shall be drawn for our products. According to Art.33 REACH, we are committed together with our suppliers, to inform our customers about the presence of substances listed as SVHC (Substances of very high concern) in the concentration of a mass fraction of > 0.1%. Further clarifications for the presence of such substances are not necessary on our part, since there are at present no informations available from our suppliers about the existence of SVHC substances in their chemicals and preparations. With the information on SVHC substances in substances and preparations by our suppliers, we will automatically operate and come unbidden to the legal obligation to furnish the information you require. We basically draw attention to the latest information from our suppliers. Laboratory tests do not occur within our works.
